

# Safety Protocol

## **Y**our Safety is our #1 Priority

We are dedicated to monitoring the Covid-19 outbreak in your state, and adhering to the guidelines set forth by the governing authorities. Implementing procedures to ensure a safe environment is our top priority.

### Infrastructure updates:

- Complimentary hand sanitizer options for all guests and participants.
- Complimentary temperature check services available for everyone.
- Everyone in attendance will be required to follow the mask protocol and guidelines set forth by the local government at the time of the event. Masks are strongly recommended; please be prepared to wear a mask if required by the local authorities.
- Entry doors kept open for events for touch-less entry.
- Social distancing guides in place on the floor for registration and for stage line-up.
- A “no contact registration” will be an available option.
- Sanitation stations will be placed in competition areas such as the dressing room, stage area, etc.
- All HMUA personnel will follow the guidelines issued by your State’s Cosmetology Board at the time of the event.

**Operational changes to reinforce safety & social distancing:**

- **Microphone Use** - Delegates will not hold the microphone during introduction or spokesmodel competition. There will be a standing mic center stage. The microphone will be sanitized frequently and/or use disposable microphone covers.
- **All On-Stage Events** - Proper hygiene and social distancing will be maintained.
- **Audience Seating** - Proper hygiene and social distancing will be maintained throughout seating areas. Members of the same family and/or quarantine group may be seated together.

**PRACTICES FOR HEALTHY VOLUNTEERS & STAFF**

**Social Distancing.** Everyone should leave at least six feet to the person closest to them, unless they are part of a regular work team or family group.

**Hand Washing.** When a sink is available, everyone should wash their hands for 20 seconds at least every 60 minutes. As a backup, workers may use hand sanitizer when a sink is not available.

**Gloves.** Everyone should wear gloves when handling money, tickets, or any item on which infection can be transmitted.

**Face Coverings.** Everyone should wear a mask whenever people are within six feet of each other unless they are part of the same quarantine or family group.

**No Contact Temperature Screening.** Anyone displaying a temperature over 100.4 will be directed to seek appropriate medical care and will be asked to return home.
